Smartlift Smartainer.

Smartainer is a flexible, intermediate bulk container (FIBC) that has been certified to UN standards and is suitable to contain packaging group II & packaging group III.

It was developed to overcome some of the limitations of existing, less practical, non-compliant hazardous waste container systems such as drums, wheeled bins and cut off rigid IBC's.

Key Features:

- Suitable to contain most hazardous solids classified under Packaging Group II & Packaging Group III
- Flexible and versatile.
- Highly visible on site.
- Space saving and easy to store.
- Suitable for restricted access areas.
- Reduced transport emissions and cost.

How this compares to other containers:

- 200ltr drums x 5 requires pallet delivery and mechanical handling.
- 1000ltr rigid IBC requires pallet delivery and mechanical handling.
- 200ltr wheeled bins x 5 requires pallet delivery and mechanical handling.



Heavy duty lifting loops

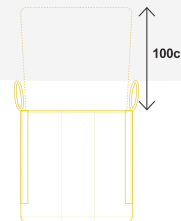


Zip top opening:

For ease of access & strong reseal.

Inner 200mu liner:

Tabbed into position & protrudes 100cm above bag for easy tie off.



Smartframe available:

For extra stability on site.



Depot Bag for Asbestos removal:
